VII. New Business:

a. Student Engagement – ESAC (R. Miller)

- We reached out to ESAC and worked with a student, Andre Wallace
- Andre did a survey within ESAC
- I was surprised about what the students are looking for.
- As a result, we collaborated with Rosette to address three main issues the students had:
 - Wanted up-to-date database of alumni (proposed QuakerNet and taking a closer look at LinkedIn)
 - Wanted mentorship program for career and personal development (Russ and Rosette discussed current available resources)
 - Wanted networking events (we pointed out work that SWE is doing and our upcoming events)
- Lots of students attended this discussion and came away with lots of ways to access what they were seeking
- Matt: Did ESAC discuss how they're going to store this information with future leadership?
 - Russ: We did talk about that, but the leadership was about to turn over. We have a good base to start with for the next year.
- Matt: Could we capture slides and/or talking points that were used to present to students?
 - Russ: I'll forward a copy of my notes for the meeting to put into the folder for next year's committee. Andre also passed along notes to all of ESAC.
- Sevile: Why didn't students know about mentoring?
 - Rosette: Lots of students want mentoring all four years and not just freshman

- We realize that people may be unavailable because of spring break, but this is a family-friendly event and the tour should be enough of a draw.
- The Penn Club of Philadelphia is advertising the event on their website.
- Brad: Is there any concern about Passover?
 - We realized that might be an issue, but wanted to try to hold it anyway.

- Sevile: There's a BE group that said they'd reimburse students if they wanted to go (\$5 attendance fee)
 - We'd originally gone with the Penn Club's suggestion of charging, and we'd use that for purchasing gifts for the panelists, but we could definitely remove that and refund those who've already paid.
- Is there a way to reach students in order for them to respond by Thursday? We haven't actually reached out to them thus far.
 - Rosette: It's difficult to get students because of how close the event is to the end of classes.
- Sevile: I'll send out an email asking people to sign up by Wednesday.
- Rosette: I'm willing to send out something to students.
- Farnia: I'll reach out to Stephanie about the fee.
- Bernard: What happened to the fee from last year's event?
 - It went to the Penn Club
- If we have a small number of people, it'll look odd because the planned space is fairly large.
- Bernard: Could we advertise it on Facebook?
- Sevile: Can you post on LinkedIn with the website? We'll give it a shot and see how it goes, and if we have to cancel, we'll cancel.
- Bernard: I'll still pull together some questions for discussion, either for use now or in the future.
